Pre-Bid RFI#5 from B&C Contractors, Inc. Dated February 5, 2024

- 1. For All 3 ES: The LVT on Finish Schedule A14.2 states that the LVT is 9"x40" and the floor pattern on print A14.1 has a herringbone pattern. As per flooring sub cannot herringbone a 9"x40" Tile, the width has to be evenly divisibly by the length, for example an 9"x36" Tile would work. Please clarify to proceed.
 - Response: The tiles are 25cmx1m or 9.845"x39.38". The length is divisible by the width. Also, the tile manufacturer lists herringbone as an acceptable installation pattern for this size tile.
- 2. Page A14.1 Detail's #29 & 30, both have the three colors of LVT but two of them have the same pattern hatching. See attached photo snippet. Please Clarify.
 - Response: The #5 and #7 callouts are correct. Tag #2 should point to the dark grey hatch and tag #3 should point to the light grey hatch in both instances.
- 3. Addendum # 03 (A-7) states delete spec section 12492, but it has been reissued with combined manual & electrical shade. Please confirm Spec 12240 should be deleted.
 - Response: Delete originally issued sections 12492 and 12240 and replace both with section 12492 (misnamed as 12240) issued in Addendum #3.



Pre-Bid RFI#2 from M&M Construction, Dated February 5, 2024

1. The LVT on Finish Schedule A14.2 states that the LVT is 9"x40" and the floor pattern on print A14.1 has a herringbone pattern. Unfortunately, you cannot herringbone a 9"x40" Tile, the width has to be evenly divisible by the length, for example 9"x36" Tile would work. Please advise.
