 - Response: Specification section 264113, herein attached.
- 4. Gilbert ES: Dwg. C-2.0 indicates 3 light Poles to be relocated with new Concrete base & rewiring few feet apart from existing locations. There is no Electrical Site Plan issued. Please confirm existing wiring to be utilized with extension as required with new light pole base only.
 - Response: Contractor shall extend/modify existing branch circuits for site lighting relocation as required.

Specification Section 11480 – Athletic Equipment was provided in Addendum #3 and makes references
